



Membership

Since Established in 2001, the Waste Management and Recycling Association of Singapore (WMRAS) aims to professionalize and develop a leading waste management and recycling industry.

WMRAS has four categories of membership:

Ordinary Membership

All Singapore-registered companies and organisations whose business activity fall within Waste Management and Recycling industry or are supportive of the objectives of the association shall be eligible to apply for admission as an Ordinary member.

Associate Membership

Any person who profession, business or company is associated to Waste Management and Recycling in Singapore. Companies or organisations who are interested in the waste management and recycling industry but do not qualify for Ordinary Membership may apply for Associate membership. Associate members are entitled to the same rights and privileges as Ordinary Members except voting rights.

Institutional Membership

Any local or foreign registered associations, institutions or societies whose activities fall within the waste management and recycling industry may apply for Institutional membership. Institutional members are entitled to the same rights and privileges as Ordinary Members except voting rights.

Individual Membership

Individual membership is offered to any person whose profession, business or company is associated to the waste management and recycling industry. Individual members have no voting rights.
